**NOTICE OF HEARING AND OBJECTION DEADLINE ON
DEBTOR’S EMERGENCY MOTION FOR AUTHORIZATION TO PAY CERTAIN

PLEASE TAKE NOTICE that on April 4, 2008, JoAnne’s Bed & Back Stores, Inc. (the “Debtor”), filed an Emergency Motion for Authorization to Pay Certain Prepetition Wages, Salaries and Other Compensation (the “Motion”). On April 4, 2008, the Debtor also filed a motion seeking expedited hearing on the Motion (the “Expedited Hearing Motion”). On April 4, 2008, the Bankruptcy Court granted the Expedited Hearing Motion, scheduled the hearing set forth herein and established the objection deadline set forth herein.

OBJECTION DEADLINE

PLEASE TAKE FURTHER NOTICE that any objection to the Motion shall be filed and served on Debtor’s counsel no later than one (1) day before the Hearing.

Any such objection must be in writing and must be filed with the United States Bankruptcy Court for the District of Maryland, Office of the Clerk, 6500 Cherrywood Lane, Greenbelt, Maryland 20770 and served (by electronic case filing, deliver or mailing a copy) upon the undersigned. The objection must contain a complete specification of the factual and legal grounds upon which it is based. IF NO OBJECTIONS ARE FILED OR

IF YOU FAIL TO TIMELY OBJECT, THE BANKRUPTCY COURT MAY GRANT THE RELIEF REQUESTED WITHOUT FURTHER NOTICE. The Court may grant the relief requested without a hearing if the objection filed states inadequate grounds for denial.
